Board Resolution / Secretary's Certificate authorizing the purchase if buyer is a corporation.

Clear photocopy of valid I.D. of Corporate Secretary and Authorized Signatory/ies of Seller & Buyer.

Board Resolution / Secretary's Certificate authorizing assigned officers to sign in behalf of the company (with signature).

Board Resolution / Secretary's Certificate authorizing assignment and stating the position of a designated Playing Representative (limited to top 4 officers of the company).

Original copy of the notarized Deed of Sale

Original copy of the Certified Authorizing Registration from the BIR

Original copy of the Capital Gains Tax return and the corresponding payment receipt

Original copy of the Documentary Stamp Tax return and the corresponding payment receipt

Two specimen Signature Cards each of seller and buyer (*signature of authorized officer/s of the company*)

Clearance from billing Department certifying that seller is free from delinquency

Payment of Processing Fee in the amount of **P 25,000.00**

Payment of the advance monthly dues, transfer fee and entrance fee upon approval.
